

### **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease over the next five years to 25.6 tCO<sub>2</sub>e by 2030. This is a reduction of 30%.

## Carbon reduction projects

#### Completed carbon reduction initiatives

The following environmental management measures and projects have been completed or implemented since the 2014 baseline. The carbon emission reduction achieved by these schemes equate to 107 tCO<sub>2</sub>e, a 73% reduction against the 2025 baseline and the measures will be in effect when performing the contract.

Completed carbon reduction initiatives:

- Installation of solar panels to office buildings.
- Change to staff homeworking since 2020.
- A move to webinar and online meetings internally, and with clients.
- A move from providing printed materials to pdf copies.
- Staff volunteer days for tree planting activities.
- Upgrading to LED lighting with movement sensors.
- Introduction of salary sacrifice car scheme, providing staff with affordable access to electric and hybrid cars.
- Offsetting carbon emission by donating to local wildlife trusts.

In the future we hope to implement further measures such as:

- As staff continue to predominantly work from home, Wider Plan will relocate to smaller offices (Unit 5) on the same development.
- Installation of solar panels to Unit 5 will reduce emissions.
- LED and movement sensor lighting.
- Using existing office furniture to reduce waste.
- Regular servicing of the aircon system.
- Continue to offset emissions by donating to local wildlife trusts.

#### Declaration and sign off

This Carbon Reduction Plan has been completed in accordance with PPN 06/2<sup>1</sup> and associated guidance and reporting standard for Carbon Reduction Plans.
